The parties hereto contract for the servicing of the said MARE by the said Stallion for the 2018 Season which ends 31st January 2019 for the *Discounted Total Breeding Fee of \$1100* (incl GST) on the following conditions:

1) FEES	Non-Refundable Booking Fee	\$ 220 (incl GST)
	Discounted Breeding Service Fee	\$ 880 (incl GST)
	Total	\$ 1100 (incl GST)

The non-refundable Booking Fee is payable on the signing of this Breeding Agreement. The Breeding Service Fee is payable at PTIF 45 days.

2) AGISTMENT Agistment will be charged from the date of the mare's arrival at Weatherford Equine until the date of departure. All Agistment fees will be paid in full to Weatherford Equine prior to mare departure.

3) All mares must be well handled and tractable to lead. Dr Joanne Smith BVSc reserves the right to refuse any mare for service.

4) LIABILITY Whilst the mare is in the custody of the stallion owner, the stallion owner shall not be liable for any sickness, disease, injury or death which may be suffered by the mare or its progeny. The stallion owner warrants all necessary precautions will be taken to ensure the wellbeing of the mare and its progeny. Should the stallion owner be unable to or fail to perform this contract by reason of death or injury or sale of the stallion, all fees paid by the mare owner will be refunded and neither party shall have any rights against the other.

5) ASSIGNMENT This contract shall not be assigned or transferred by the mare owner without written consent of the stallion owner.

6) LIVE FOAL GUARANTEE In the event the mare aborts or if the foal does not stand and nurse, it is agreed that the mare owner may return the mare for the 2019 breeding season (handling and full vet fees will apply) and no breeding service fee will apply. To be entitled to such subsequent breeding, the mare owner must notify the stallion owner within 48hrs from foaling. The mare owner must also give notification with a veterinarian's certificate of the foal's death within 14 days of such death. If the mare does not become pregnant in the 2019 season or give birth to a live foal the mare owner shall not be entitled to any further free services or refund of service fee.

7) REBREEDS Rebreds will only be held over to the breeding season immediately following the initial booking. Should the rebreed not be taken up in the immediately following season the Breeding Agreement will be deemed to be completed and all rebreeding rights forfeited. Semen collection and shipping fees will apply to all rebreeds and will be the responsibility of the mare owner. Any collection and shipping fees are payable prior to the shipment of any semen.

8) VETERINARY FEES All veterinary expenses incurred for the mare are the responsibility of the mare owner.

9) BREEDING CERTIFICATES AQHA breeding certificates will not be issued unless the above mentioned mare is registered with the AQHA at time of signing this contract. If a late stallion breeding return is required the mare owner is liable to pay the late fee required by the AQHA. ASH breeding certificates will be issued to registered ASH mares. If Registration papers are not provided with this contract- no Breeding certificate will be issued.
