STALLION SERVICE  
AGREEMENT**



This Stallion Service Agreement, for the 2018 breeding season, is by and between LC Partnership (“Stallion Owner”) And (“Mare Owner”) \_\_\_\_\_

**1. Mare.** This agreement will apply to the following mare (“Mare”):

**2. Stallion.** Subject to the other terms and conditions of this Agreement, Stallion Owner will ship Mare Owner semen from **HAZELWOOD CONGRESSMAN, ASH # C2-232770**, for the sole purpose of inseminating Mare.

**3. Service Fee.** Mare Owner agrees to pay Stallion Owner the “Service Fee” of AUD \$1650 (inc GST). **The Service Fee includes a non-refundable booking fee of \$330 (inc GST)**, payable upon execution of this agreement and prior to semen collection. **The balance of the Service Fee is payable upon 45 days positive pregnancy test.** Agreement does not include any veterinary, collection, freight or any other costs incurred by Mare in achieving a pregnancy. Interest charged at the current commercial rate will be charged on all outstanding monies.

**4. Collection & Shipment of Semen.** SEMEN WILL ONLY BE PROVIDED AFTER BOOKING FEE IS PAID AND STALLION OWNER HAS RECEIVED A SIGNED AGREEMENT AND COPY OF MARE’S REGISTRATION PAPERS. Stallion Owner guarantees to ship the highest quality semen, however will make no guarantees or warranties and shall not be held liable for contamination or damage of semen during or after shipment, loss of viability or any costs arising from shipments delayed, damaged or lost in transit.

**5. Live Foal Guarantee.** This agreement entitles Mare Owner to a Live Foal Guarantee, whereby if the foal dies within forty-eight (48) hours of foaling or if the foal is stillborn, the Mare Owner will be entitled to a free return the following year only to the same mare (unless otherwise mutually agreed). If the mare fails to produce a live foal, is unsuitable to breed, is sold or dies in the return service year, the Stallion Owner shall be released from any further obligations. **THIS GUARANTEE WILL APPLY ONLY IF THE MARE OWNER NOTIFIES LC PARTNERSHIP WITHIN ONE (1) WEEK FROM DEATH; THIS NOTICE MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENSED VETERINARIAN.** The Live Foal Guarantee is non-transferable and non-assignable unless authorised by LC Partnership.

**6. Other Conditions.**

- Mare Owner agrees that the details of the above named Mare are true and correct and that Mare is in a healthy and sound breeding condition. This fact to be certified by veterinarian if required. All semen shipped pursuant to this Agreement shall be used for the sole purpose of inseminating said Mare.
- If embryo transfers result in more than one pregnancy, Mare Owner must pay Stallion Owner the Service Fee for each pregnancy.
- The Mare Owner agrees to notify the results of pregnancy scans regardless if Mare is pregnant or open. Once all fees are paid by the Mare Owner and the positive veterinary certificate received, LC Partnership will post the ASHS Certificate of Breeding.
- If after an extended period of multiple attempts, the mare fails to achieve a pregnancy this contract will be reviewed between the parties.
- Stallion Owner reserves the right to refuse service on any mare at their discretion.
- The Parties agree that should The Stallion be unavailable for any reason, die or be unfit for service after payment of the stallion fee, but prior to a pregnancy being achieved, the Mare Owner shall be entitled to a refund of the Stallion Service Fee.
- This contract shall not be transferable by the Mare Owner. This agreement constitutes the entire agreement between the Parties and any amendments or modification of the terms to this agreement must be in writing.
