



# STALLION SERVICE CONTRACT

We/I \_\_\_\_\_ the Mare Owner, here by agree to breed to the Stallion "One Direction" ASH 233309 in the 20\_\_/20\_\_ breeding season.

Service Fee \$1650.00 inc GST, plus Agistment & Vet services. The following conditions apply:

1. A booking fee of \$330.00 (**non-refundable**) is payable at the time of booking mare to Stud. **The booking fee is deductible from the service fee and is valid for one breeding season only.**
2. The said mare to be bred shall be healthy and in sound breeding condition, this fact to be certified by the Veterinarian if required.
3. Mare Owners agree to only book mares that are halter broken and gentle.
4. This contract shall not be assigned or transferred by the Mare Owner unless written consent is obtained from the Stud Management.
5. A copy of the mare's registration papers is also required with booking.
6. All prices quoted in this contract are G.S.T inclusive.
7. It is further agreed that the said Stallion be unavailable for any reason whatsoever before serving the said mare, or if the said mare in the named contract dies or becomes unfit to be served then this contract shall become null and void.

**LIVE FOAL GUARANTEE** (For this purpose live foal shall be defined as a foal that stands and nurses without assistance.) The Stallion Owner will supply a free return the following breeding season if a live foal fails to result from mating. The Mare Owner will give notice to the Stud no later than 48 hours of the mare foaling or aborting. If this is not forthcoming the live foal guarantee will be null and void. A further booking fee applies for each breeding season a mare returns.

**ARTIFICIAL INSEMINATION** (A.I) with chilled semen is available to mare owners at designated Veterinary Clinics (approved by Stallion Owner). All associated insemination costs shall be met by the Mare Owner and all transport cost by the Mare Owner. SHIPPED SEMEN FEES are to be paid by the mare owner. The mare owner undertakes to employ the services of an accredited artificial insemination equine breeding veterinarian preferable listed by the Australian Veterinary Association.

**NO WARRANTY** Stallion Owner & Donell Park Stud make no warranty or guaranty, express or implied, with respect to the Fresh or Frozen semen, including without limitation, the warranty of fitness for a particular purpose. Semen manager makes no guarantee of delivery within a certain time period and makes no guarantee that the fresh or frozen semen will arrive at its destination point without losing integrity, quality or characteristics.

The mare owner will inform Donell Park Stud of the results of the 16 Day pregnancy check and an invoice for the remaining monies owed will be issued if there is a positive result. The service fee is to be paid in full ON 42 DAY Pregnancy Test. A "Breeder's Certificate" will be issued when all monies due under the agreement have been paid.
