



## STALLION BREEDING CONTRACT

I, \_\_\_\_\_

hereby agree to breed my Mare \_\_\_\_\_

to **MOORE METAL** (AQHA No. 79373) during the 2023-24 Breeding Season with a Live Foal Guarantee.

- The Service Fee of \$1980.00 (inc GST) includes a \$330.00 (inc GST) non-refundable Booking fee.
- Semen will not be released until the Contract is completed and Signed with the Booking fee being paid.
- The balance of the Service fee will be due upon a positive 15-day pregnancy scan from the vet.
- All Veterinary expenses, collection fees and shipping costs of Chilled or Frozen semen are at the expense of the mare's owner. Stallion owner shall not be held liable for damage of semen, loss of viability or any costs arising from shipment delays or lost in transit. **No live cover available.**
- Frozen Semen will be sent in two (2) breeding doses at the mare owners' expense. Any unused frozen semen is to be returned to the location that originally shipped the semen.
- Frozen Semen will incur a Collection Fee of \$250 (plus GST) per dose used. Eight Straws (8) in a dose.
- A live foal is defined as one that will stand and suck. If a foal is born dead or dies of natural causes within 7 days, the mare owner will be entitled to a re-breed to the same mare (unless mutually agreed) until a healthy live foal is achieved. This guarantee will only apply if a written statement from a Licensed Veterinarian is produced within 7 days from the death. If the mare fails to produce a live foal in the return service year, the stallion owner shall then be released from any further obligations unless an agreement has been reached to continue.
- The mare owner agrees to notify the stallion owner of the results of the pregnancy scan regardless if she is pregnant or open, and agrees to provide a veterinary certificate of the **45-day pregnancy scan**.
- Upon payment of all fees and a positive pregnancy test has been certified a Breeding Certificate will be sent out prior to the foal being born.
- The mare owner must inform the stallion owner if this is an Embryo transfer and if multiple embryos are produced from a single flush, the mare owner agrees to an additional breeding fee for each additional live foal.
- If the stallion should die or become unfit for any reason whatsoever after the service payment has been paid, but prior to a pregnancy being achieved, the mare owner will be entitled to a full refund and this contract will become null and void.
- A Service fee (less deposit) can be refunded or transferred to the following year if a mare fails to fall pregnant throughout that breeding season. Another mare may be chosen to breed with in replacement of the existing mare, if the owner continues to breed but only at the Stallion owner's discretion.
- Upon signing of this contract, the mare owner certifies that he or she has the authority to enter this contract and agrees to provide a **Certificate of Registration** for the mare.
- **Mare owner and Veterinarian agree that shipped semen is to be used only on mare nominated in this contract.**
- This contract is not transferrable by the mare owner and cannot substitute with any other mare unless prior written consent from the stallion owner.
- Owners must inform the Stallion owner of the mare's pregnancy prior to the **30<sup>th</sup> April 2024** for the purposes of obtaining a breeder's certificate with the relevant associations. Late registrations will incur addition costs.


