To: REYS YA GARTER Q-59611 during 2023/2024 BREEDING SEASON. The breeding fee of \$2,200 GST Inclusive.
- Frozen Semen will incur a Collection Fee of \$275 (GST Inclusive) per dose used. Eight Straws (8) in adose.
- Payment will be made to: **TRUE BLUE (AUST) INTERNATIONAL P/L**
The breed fee shall entitle the mare owner to a Live Foal Guarantee
- The mare owner understands that the amount stated about does not include any veterinary cost incurred in achieving a pregnancy.
- Is the semen to be shipped _____
- Mr Corey & Trudy Holden guarantee to ship the highest quality semen, however will make no guarantees or warranties and shall not be held liable for contamination or damage of semen during or after shipment during or after shipment, loss of viability or any cost arising from shipments delayed, damaged or lost in transit.
- We must be notified of a positive or negative pregnancy before the **28th February 20** _____ to make sure the breed return is lodge on time, if notified after this time the cot WILL be forward and must be paid before you are issued with a breeding certificate.
- If more than one foal results from any one (1) embryo flush, an additional stallion breeding fee of **\$2,200 GST Inclusive** will be due and payable to **TRUE BLUE (AUST) INTERNATIONAL P/L** upon each successful pregnancy od said embryo(s).
- Mare owner agrees to notify Mr Corey & Trudy Holden of the pregnancy status of the mare as soon as she is checked for pregnancy regardless if the mare is pregnant or not.
- Mare owner agrees to give the mare amply opportunity to settle (having bred her through at least (3) breeding cycles). If however, for any reason she does not settle, mare owner will hold Corey & Trudy Holden harmless.
- It is also agreed that the mare owner is guaranteed a live foal at the time of this signing of this contract and that if the foal does not stand and stuck, the mare owner will be entitled to a rebreed to the same mare (unless mutually agreed) until a healthy live foal is achieved.
THIS GUARANTEE WILL APPLY ONLY IF THE MARE OWNER NOTIFIES COREY AND TRUDY HOLDEN WITHIN ONE (1) WEEK FROM THE DEATH; THIS NOTICE MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENCED VETERINARIAN.
There shall be no liability upon Corey & Trudy Holden on account of said guarantee except to grant the mare owner a rebreed for one(1) mare until a successful healthy live foal is achieved. Said rebreed shall refer to the breeding fee only. Rebreed contract must be filled out and returned to Corey & Trudy Holden immediately.
- THE LIVE FOAL GUARANTEE FOR THIS CONTRACT IS A NON-TRANSFERABLE AND NON-ASSIGNABLE** unless authorized by Corey & Trudy Holden. Should mare be sold or otherwise disposed of prior to the birth of the foal. The LFG shall be void uness prior authorization by Corey & Trudy Holden.
- All expenses including shipment incurred in achieving rebreeds shall be borne by the mare owner.
- The mare's registration certificate showing owner at the time of breeding or a photocopy of both sides, thereof, must be furnished and returned with this contract.
- SEMEN WILL NOT BE SHIPPED UNTIL THE SERVICE FEE IS PAID IN FULL AND A SIGNED CONTRACT AND A COPY OF MARE'S REGISTRATION PAPERS ARE ON FILE WITH COREY AND TRUDY HOLDEN.**
- When the mare owner signs and returns a copy of this contract with proof of payment/ or receipt. It will be a binding contract on both parties and subject to the above terms and conditions.
Mare owner agrees not to assign or transfer this contract without prior consent of Corey & Trudy Holden.
