FEES WALLABAH EXCEL:

- Non-refundable, but deductible booking fee: \$400.00 + GST = \$440.00
- Breeding Service Fee: \$3,600.00 + GST = \$360.00 payable when the mare is pronounced in foal
- TOTAL FEE: \$ = \$4,400
- The \$440.00 booking fee is non refundable and is deducted from the service fee, it is payable on the signing of the breeding agreement and is valid for one breeding season only, unless a rebreed is required.
- A rebreed must be used the year immediately following the initial breeding
- A mare will not be bred until booking fee is paid

FEES TRAVERS CONFIDENCE:

- Non-refundable, but deductible booking fee: \$150.00 plus GST \$15.00 = \$165.00
- Breeding Service Fee: \$1350.00 plus GST \$135.00 payable when the mare is pronounced in foal

- TOTAL FEE: \$1500.00 plus GST \$150.00 = \$1650.00
- The \$165.00 booking fee is non refundable and is deducted from the service fee, it is payable on the signing of the Breeding Agreement and is valid for one breeding season only, unless a rebreed is required.
- A rebreed must be used the year immediately following the initial breed.
- A will not be bred until booking fee is paid.

AGISTMENT:

- Agistment will be charged from the day of mare's arrival at the stud until the date of departure
- Dry or wet mare agistment will be charged at an agreed daily rate and include GST
- Agistment is charged at \$50 per week for dry mares and \$70 per week for wet mares.

VETERINARY:

- All veterinary expenses incurred for the mare, including pregnancy tests, will be paid by the mare owner
- Any collection or shipping of semen fees will be paid by the mare owner.
- The mare owner warrants that to their knowledge the mare is in good health, in sound breeding condition and has not been in contact with contagious equine metritis, strangles or any other infectious disease.
- The stallion owner or agent may at any time at the expense of the mare owner have the mare examined for any such infectious disease

SERVICE CERTIFICATE:

- An ASH or AQHA service certificate will be supplied at no charge, following the successful birth of a live foal.

LIABILITY:

- Whilst the mare is in the custody of the stallion owner or agent the stallion owner or agent shall not be liable for any sickness, disease, injury or death which may be suffered by the mare or its progeny.
- The stallion owner warrants all necessary precautions will be taken to ensure the well being of the mare and its progeny.

CONDITIONS:

- This contract shall not be assigned or transferred by the mare owner without written consent of the stallion owner.
- When the mare owner signs and returns a copy of this contract to Simon and Debbie Dodwell, it will then be binding contract on both parties subject to the above terms and conditions.
- In the event that the mare aborts or if the foal does not stand and nurse, it is agreed that the owner may return the mare for breeding during the following breeding season and no service fee will be charged for subsequent breeding.

- To be entitled to such subsequent breeding, the owner must deliver to Simon and Debbie Dodwell, a certification by a licensed veterinarian attesting that the mare aborted or that the foal failed to stand and nurse, accompanied by the Stallion Breeding Certificate, and such delivery shall be made within ten (10) days of the date that the mare aborts or the foal is born.
- The parties agree that if the stallion dies or becomes unfit for service after payment of the service fee but prior to a positive pregnancy test, the mare owner shall be entitled to a refund of the stallion service fee.
