

THIS CAT'S DESTINY live Cover Breeding Agreement.

1. (Mare Owner)_____ here by agree to breed the mare_____ registration number _____ to This Cat's Destiny during the 2020/21 breeding season, which ends the 1/2/2021.
2. The breeding fee for the 2020/21 breeding season is \$1650, this includes a \$550 non-refundable booking fee that is payable to Morgy's.
- 2a. A Covid 19 extension has been added. The breeding fee will be \$1650 for all who have forwarded all paperwork required and a \$550 deposit before the 1st of October 2020.
3. The mare owner understands the amounts stated above do not include any veterinary, collection, shipping, agistment, or other cost incurred in achieving this pregnancy.
4. Mare owner agrees to give the mare ample opportunity to settle (having breed her through at least three (3) breeding cycles). If, however for any reason she did not settle, mare owner will hold Morgy's harmless.
5. It is also agreed that the mare owner is guaranteed a live foal at the time of signing of this contract and that if the foal does not stand and suckle the mare owner will be entitled to a re breed of the same mare or another mare of similar standing(to be discussed with Morgy's) until a healthy live foal is achieved. This guarantee will apply only if the mare owner notifies Morgy's within 48hrs from death. The notice must be accompanied with a statement from a licensed veterinarian. There shall be no liability on Morgy's on account of the said guarantee except to grant the mare owner a rebreed for one mare until a successful live foal is achieved. Said rebreed shall refer to the breeding fees only. Rebreed contract must be filled out and returned to Morgy's .
6. The live foal guarantee for this contract is non-refundable, transferable and non-assignable unless authorised by Morgy's. Should mare be sold or otherwise disposed of prior to the birth of the foal, the live foal guarantee shall be void unless prior authorisation by Morgy's.
7. All expenses incurred in achieving rebreeds shall be borne by the mare owner.
8. A photo copy of mare's registration papers must be returned with this contract.
9. Mare will not be covered until a clear cervical/virginal swab is received by Morgy's.
10. Mare will not be covered until booking fee is paid in full and a signed contract and a copy of mare's registration papers are on file at Morgy's. The balance is payable and due on a positive pregnancy test at 42days.
11. Morgy's reserve the right to refuse the breeding of any mare that does not have ideal health and/or handling standards.
12. When mare owners sign and returns this contract with fees payable to Morgy's it will be a binding contract on both parties and subject to the above terms and conditions. Mare owner agrees not to assign or transfer this contract without prior consent of Morgy's.
