➤ Live cover will not be available prior to full payment of relevant service fee.			
➤ Mares must be in healthy and sound breeding condition. <b>NB - Please note that if the mare is not a maiden mare a swab will have to be collected by a vet and tested for equine venereal diseases prior to being covered.</b>

➤ **LIVE FOAL GUARANTEE:** If the mare aborts, or the foal does not stand and nurse, or dies within 48 hours of its birth, the mare is allowed a free rebreed to the stallion in the following season. This guarantee is null and void if the stallion owner is not notified within one week of the foal's demise or when the mare is found to have aborted.

**Live Foal Guarantee is non-transferable without the prior consent of the stallion owner.**

➤ If the mare does not settle, the mare will be eligible for a free rebreed in the following season.

➤ This contract is non-transferable in part or whole without the consent of the stallion owner.

➤ The mare owner accepts that they are responsible to advise all confirmed pregnancies to the stallion owner before 30 April 2025. Failure to do so will result in any additional costs being passed on to the mare owner.
