I/we, \_\_\_\_\_ the mare owner, agree to breed the mare \_\_\_\_\_ to the stallion  
"Brother Tuff Wood " AQHA- Q-97311 (Stallion) in the 20\_\_\_/20\_\_\_ breeding season on the following conditions:

1. The Service Fee stated above includes a non-refundable booking fee of **\$550.00** (inclusive of GST) which shall be payable upon execution of this contract. The balance of the Service Fee being **\$2,200** (inclusive of GST) shall be payable when the Mare is pronounced 45 days in foal. The mare owner agrees to notify the results of pregnancy scans for the Mare regardless of result.
2. The booking fee is valid for the Breeding Season only, unless a rebreed is required, in which case, it must be used the year immediately following the Breeding Season.
3. The semen will not be shipped and/or the mare will not be bred until completed contract, copy AQHA / ASHS registration papers & booking fee is paid.
4. All fees associated to the breeding of the Mare are payable to Tuff Syndicate P/L.
5. The Stallion will be standing at 'Beef Breeding Services"
6. Chilled semen collections will take place at **Beef Breeding Services**
7. When standing at **Beef Breeding Services** , a Chilled Semen Collection fee of \$TBA Excluding GST will apply.
8. Frozen Semen is Available upon request at a Flat fee of \$220.00 + Semen Freight,If Chilled is not Available.
9. All costs associated with the freight of chilled or frozen semen will be charged to the client including the return of the semen box and semen shippers.
10. The contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If the foal is born dead or does not stand and nurse without assistance, the mare owner is entitled to a rebreed in the following breeding season. In this case, the mare owner must provide notice to **TS P/L** within seven (7) days of the birth of the foal, accompanied by a statement from a Licensed Veterinarian which confirms the status of the foal.
11. If the Mare miscarries, proves barren after being pregnancy checked in-foal or fails to conceive during the Breeding Season, TS agrees to breed the Mare again during the following breeding season. A substitute mare may be sent if, at the discretion of TS, the Mare is deemed unfit for breeding.
12. The mare owner agrees to maintain the Mare in good condition during the term of her pregnancy.
13. ASHS/ AQHA breeding certificates will be issued on request provided that **TS P/L** has received all payments in full.
14. Any AQHA breeding return must be requested by the mare owner by March of the Breeding Season. If an AQHA breeding return is requested after March in the Breeding Season, the mare owner will be responsible for the expense.
15. If the Stallion dies or becomes unfit for service for any reason prior to covering the Mare, this contract will terminate, and any expenses incurred by the mare owner such as veterinary fees etc. shall be paid by the Mare owner. If the Mare dies, then this contract will be terminated.
16. In the event that the Mare does not go into foal after a first Cycle, the mare owner will be contacted with the option to use a Licensed Veterinarian. The mare owner will be responsible for all veterinary fees and charges for breeding, agistment etc. associated with that procedure.
17. The mare owner agrees that the Service Fee does not include any veterinary costs incurred in achieving a pregnancy including but not limited to collection, insemination, scanning, treatment drugs, worming, treatment, preventive measures, examination, embryo transfer etc. as necessary, mare-handling fees, agistment of the Mare, semen transport, and any other related expenses, which amounts are to the account of the mare owner.
18. If more than one foal results from any one embryo flush, the mare owner will be liable for an additional fee of **\$2,750** (inclusive of GST) for each successful pregnancy, which amount is due and payable when the mare is 45 days in foal.
19. Every effort will be made to ensure that the chilled semen arrives in the best possible condition and at the agreed time as stated by the freight company. However, we are powerless if the freight company loses the semen or fails to deliver to the agreed place. We accept no responsibility for such loses & reserve the right to charge repeat collection fees & freight fees if required. Negotiations between the mare owners & the freight company will not be our responsibility in such cases

20. In respect of the first progeny of the Stallion bred under this form of agreement to win any one of the NCHA Open Futurity, Nutrien Classic, Condamine Bell, Warwick Gold Cup, Chinchilla Grandfather Clock (hereafter called the 'Winning Progeny'), the Proprietor will pay an Incentive of \$50,000 including GST (if any) as follows:

21. Three fifths of the Incentive to the owner of the Winning Progeny only if recorded in either the Australian Quarter Horse Association or Australian Stock Horse Association registers at the time of crowning of the event;

22. Two fifths of the Incentive to Mare Owner as entered this form of contract with the Proprietor, giving rise to the siring of the Winning Progeny.

23. The winner of an event is to be determined by the rules of the individual event, but in the case of any genuine dispute, the Proprietor may acting reasonably determine if there is a Winning Progeny and if so what horse, and the Proprietor's decision shall be final and binding.

24. In respect to the \$25,000 to Toowoomba Nutrien supreme Sale 2yo incentive, ARBC Australia's Greatest Horsemen & Nutrien Classic Challenge . In respect to the \$20,000 to the Cloncurry Stockmans Challenge, NCHA Open & NP Snaffle Bit. As per the Conditions in section 23 & 25 this incentive will then be Extinguished

25. For the avoidance of doubt, this clause operates only once. Once one incentive payment is made pursuant to this clause, the Proprietors obligations under it are extinguished. The Proprietor is not obliged to pay any subsequent winner of any event.
