This Contract is between Nathan Wilson Training Stables (herein after referred to as “The Partnership” and “The Horse Owner”, _____ . Whereas The Partnership has agreed to train the horse _____ owned by The Horse Owner, upon the Terms and Conditions herein after.

1. TRAINING FEES

Training Fees will be charged at \$55 incl. GST per ride/session. Ride duration is approximately 30 minutes. Fees and charges will be invoiced every 14 days and are payable within 7 days. Interest charged at the current commercial rate plus collection costs will be charged on all outstanding monies.

2. CHARGES

The Horse Owner agrees to pay all charges applicable to the horse, for, but not limited to, agistment fees, all treatments, examinations, procedures, operations and medicines administered whether by Stud Veterinarian, employees of The Partnership or others, and any other costs incurred by The Partnership during the horse’s stay at Nathan Wilson Training Stables. Interest at the current commercial rate will be charged on any outstanding monies not paid within twenty-one (21) days after an account has been rendered. Collection costs will be applied to all late payments.

Veterinary services for the horse will be conducted at the discretion of The Partnership in consultation with the Stud Veterinarian. Veterinary procedures are payable by The Horse Owner. The Horse Owner warrants that the details on the abovementioned horse contained in the Application Form are true and correct and that the horse shall be healthy and in sound condition.

The Partnership has the right to refuse training to any horse at their discretion. The Horse Owner also agrees that The Partnership will not be responsible for any disease, accident, sickness or death to the Owner’s horse. This Contract shall not be assigned or transferred by The Horse Owner and in the event that the said horse is sold, any and all outstanding fees, shall immediately become due and payable by the undersigned Horse Owner.

3. OTHER

On arrival at Nathan Wilson Training Stables, the horse must be accompanied by the Certificate of Registration, as issued by the ASHS, AQHA or other relevant Breed Societies. Current worming and vaccination dates are to be supplied. If not, The Horse Owner agrees that The Partnership has the right to administer any vaccinations and/or drenches it deems necessary at The Horse Owners cost.

The Partnership shall provide all care, good husbandry and attention to the horse in their charge. However, takes no responsibility for injury, sickness, disease or death of any horse whilst in their care. On signing this training contract, I understand and agree to the terms and conditions and accept all liability and responsibility associated with the services provided by Nathan Wilson Training Stables.
