



2023 Australian Breeding Contract

1. I hereby agree to breed my mare: _____ Reg.# _____, to the Stallion: _____

_____ during 2023. The breed fee of \$ _____ + \$ _____ GST includes a non-refundable booking fee of \$550.00 (GST Included) made payable to Buffalo Ranch (All fees are payable in Australian Dollars). The Breeding Fee shall, entitle me to the Buffalo Ranch Live Foal Guarantee LFG (see paragraph #10).

2. I understand that the amounts stated in Par. 1 above do not include any costs incurred in achieving a pregnancy.

3. **Buffalo Ranch reserves the right to approve all locations where semen is to be shipped, and will only ship to those locations which are trusted to handle and account for the semen properly.**

4. 2 breeding doses of frozen semen shall be sent at mare owners expense. Mare owner and veterinary clinic understand that shipped semen is to be used only on approved mare in this contract and any unused frozen semen shall be returned to the location that originally shipped semen, at the mare owners expense.

5. Buffalo Ranch guarantees to ship the highest quality semen. However will make **no guarantees or warranties and shall not be held liable for contamination or damage of semen during and after shipment, loss of viability or any costs arising from shipments delayed, damaged or lost in transit.**

6. A fee of \$100 + GST and transport fees are payable for each additional dose of frozen semen required to achieve a pregnancy over the initial 2 doses supplied with this contract.

7. Is this mare to be an embryo transfer? Yes No (circle one).

If yes, name of embryo transfer facility: _____. If more than one foal results from any one (1) embryo flush, an additional Stallion Breed Fee of \$ _____ + \$ _____ GST will be due and payable to Buffalo Ranch upon each successful 45 day pregnancy check.

8. I agree to notify Buffalo Ranch International of the pregnancy status of the mare as soon as she is checked for pregnancy regardless if the mare is pregnant or open.

9. I agree to give *SEE BELOW ample opportunity to settle her (having bred her through at least three breeding cycles). If however, for any reason she does not settle, I will hold Buffalo Ranch harmless.

10. It is also agreed that I am guaranteed a live foal at the time of the signing of this contract and that if my foal does not stand and suck, I will be entitled to a rebreed to the same mare (unless mutually agreed) until a healthy live foal is achieved. **THIS GUARANTEE IS BETWEEN THE STALLION OWNER AND THE MARE OWNER. SDP BUFFALO RANCH IS AN ACTING AGENT. IT WILL APPLY ONLY IF I NOTIFY BUFFALO RANCH WITHIN ONE (1) WEEK FROM DEATH; THIS NOTICE MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENSED VETERINARIAN.** There shall be no liability upon Buffalo Ranch on account of said guarantee except to grant me a rebreed for 1 mare until a successful healthy live foal is achieved. Said rebreed shall refer to the Breeding Fees only. **Rebreed contract must be filled out and returned to Buffalo Ranch immediately.**

11. If the resulting foal is genetically proven through DNA test to be HERDA Hr/Hr, full rebreed privileges will be granted on a mare that is proven HERDA N/N by DNA test. A letter from a veterinarian and copy of DNA report for said foal will need to be submitted for rebreed privilege.

12. **THE LIVE FOAL GUARANTEE FOR THIS CONTRACT IS NON-TRANSFERABLE AND NON-ASSIGNABLE unless authorized by Buffalo Ranch.** Should mare be sold or otherwise disposed of prior to the birth of the foal, the LFG shall be void unless prior authorization from Buffalo Ranch.

13. **SEMEN WILL NOT BE SHIPPED UNTIL FEES ARE PAID IN FULL AND A SIGNED CONTRACT AND COPY OF MARE'S REGISTRATION PAPERS ARE ON FILE AT BUFFALO RANCH International.**

14. When mare owner signs and returns one copy of this contract with fees payable to Buffalo Ranch, it will then be a binding contract on both parties and subject to the above terms and conditions. I agree not to assign or transfer this contract without prior consent of Buffalo Ranch.
