

# **Breeding Contract 20\_\_\_**

We/I \_\_\_\_\_ the Mare Owner, here by agrees to breed to the Stallion "Makenn Shekeras Destiny" Q-85204 in the 20\_\_\_\_ breeding season. Service Fee \$1,980 inc GST, plus Agistment and Vet services. The following conditions apply: -

- A booking fee of \$440 inc GST (non-refundable) is payable at the time of booking mare to Stud. The booking fee is deductable from the service fee and is valid for one breeding season only.
- 2. The said mare to be bred shall be healthy and in sound breeding condition, this fact to be certified by the Stud veterinarian if required.
- 3. The Stud Management has the right to refuse service on any mare at their discretion and money paid under provisions of Paragraph 1, hereof shall be refunded to the Mare Owner.
- 4. The Stud shall provide all care, good husbandry, and attention to the mare and/or progeny in their charge However the Stud Management takes no responsibility for injury, sickness, disease or death of any mare or foal whilst in their care.
- 5. The Stud management reserves the right to obtain any veterinary attention it considers necessary to horses left in its care without further consultation. In all cases the Stud Management undertakes to take all reasonable measures to contact Mare Owners where veterinary cost are to be paid by the Mare Owner.
- 6. Mare owners are requested to contact the Stud Management at least 24 hours prior to removing their Mares from the Stud.
- 7. Mares will not be released until all monies owing are paid in full to the Stud. The service fee is to be paid in full to their lease of the mare, unless the mare is tested negative prior to leaving the Stud. Should the mare leave the Stud prior to being pregnancy tested the service fee is required to be paid in full.
- 8. Mare Owners agree to only book mares that are halter broken and gentle.
- This contract shall not be assigned or transferred by the Mare Owner unless written consent is obtained from the Stud Management.
- 10. A copy of the mare's registration papers is also required with booking.

11. All prices quoted are GST inclusive.

Live Foal Guarantee: (For this purpose live foal shall be defined as a foal that stands and nurses without assistance.) The Stallion Owner will supply a free return the following breeding season if a live foal fails to result from mating. The Mare Owner will give notice to the Stud no later than 48 hours of the Mare foaling or aborting. If this is not forthcoming the live foal guarantee will be null and void. A further booking fee applies for each breeding season a mare returns.

**Artificial Insemination (A.I.):** with chilled semen is available to Mare Owners at designated Veterinary Clinics (approved by Stallion Owner). All associated insemination cost shall be met by the Mare Owner. Semen will be collected by Equivet Breeding Centre and all collection will need to be paid directly to either. Shipping costs will be met by the Mare Owner. (For details of estimate costs apply to Equivet Breeding Centre.)

**Shipped Semen:** Collection & Shipped Semen fees are to be paid by the mare owner to Equivet Breeding Centre before shipment (please contact Equivet Breeding Centre.)

Diligent efforts must be made to get the mare pregnant. The Mare Owner undertakes to employ the services of an accredited artificial insemination equine breeding veterinarian preferable by the Australian Veterinary Association.

NO WARRANTY: Stallion Owner makes no warranty or guarantee, express or implied, with respect to the Fresh or Frozen Semen, including without limitation, the warranty of fitness for a particular purpose. Semen manager makes no guarantee of delivery within a certain time period and makes no guarantee that fresh or frozen semen will arrive at its destination point without losing integrity, quality or characteristics. The Mare Owner will inform Stan & Nerida McLeish of the result of the 16-day pregnancy check and an invoice for the remaining monies owed will be issued if there is a positive result. A "Breeder's Certificate" will be issued when all monies due under the agreement have been paid.
