2023 Breeding Contract

1. It is agreed that the Owner shall breed 'Rapid Flo' Q-95361 to the
mare; Registration #
For the 2023 breeding season at the breeding Fee of \$1,650 inclusive of GST.

2. A non- refundable Breeding Fee of \$1,650 shall be paid on the signing of this breeding contract.

3. Breeding Fee must be paid in full before first shipment of semen is sent.

4. The Owner shall return this breeding contract duly signed together with a photocopy of the mare's
registration papers. The Stallion Owner/ Authorised Agent of the stallion shall sign the same form to form a
binding Contract & return one photocopy of the signed contract to the mare owner. Should this contract
be for a DONATED OR OTHER WISE arranged breeding, please make this noted on the contract when
returned.

5. Shipped Semen

- a) The Owner agrees that a licensed Veterinarian who is qualified & experienced in the use & handling
of chilled semen will perform the insemination.
- b) The Owner also agrees to use all semen provided by this contract for the mare named in this
contract and no other.
- c) All semen collection fees must be paid before semen is despatched by the Mare Owner. Go to the
Hagons Equine website - www.hagonsequine.com.au/semenrequestform to request semen collection.

6. Live Cover

- a) Mare must be in healthy and sound breeding condition, and free from infections, contagious and transmittable disease.
- b) Purchaser may not substitute another mare for breeding without prior, written consent of James or Olivia Vickery.
- c) The mare’s health and mortality are the full responsibility of the mare owner before, during and after this breeding. If the mare has a foal at her side, the foal’s health and mortality are also the full responsibility of the mare owner before, during and after breeding.

7. The Mare Owner shall be entitled to a live foal guarantee with return privilege in the following season, on the following conditions.

- (a) Does not conceive in the 2023 season; OR
- (b) If the foal is absorbed, aborted or dose not stand up & nurse.

8. If the Owner fails to make arrangements for a re-breed in the following season, the return privilege is lost & the deposit is forfeited. This re-breed shall apply only if Vanzed Pty Ltd is notified within one (1) week of the death of the foal. This notification must be accompanied by a statement from a licensed veterinarian, stating the cause of death. Vanzed Pty Ltd sole liability and obligation for any foal that is born to the mare but does not stand and nurse, shall be the granting of a re-breed. Such breeding shall apply to the Breeding Fee only and only to the season immediately following the season set forth in this contract.

9. This contract provides for one (1) Breeder’s Certificate. If multiple embryos are retrieved from one breeding, it will be the responsibility of the Mare Owner to notify Vanzed Pty Ltd of number transferred and once there is additional embryos at 60 days positive pregnancy check, an additional Breeding Fee(s) of \$1,650 will be due. If multiple embryos are desired and it takes more than one breeding, an additional contract is required for each breeding. Please notify Vanzed Pty Ltd with the status (In Foal/Open) of your mare at the end of the breeding season.

10. Should the stallion die or become unfit for service, the breeding fee will be refunded.

11. The Stallion Owner may agree to a transfer of the contract should the named mare be sold; or to a substitution of the named mare should the named mare die, or be unable to be bred; otherwise, this agreement is not transferable and applies to the named mare only.

12. Owner shall hold Stallion Owner and Vanzed Pty LTD harmless for any accident, injury, theft, disease, sickness, or death suffered by the mare and/or foal, or any other cause of action whatsoever arising out of or connected in any way with Shipped Semen Breeding. This includes but is not limited to, any claims of damages, loss or injury that may occur to any person or personal property.

13. This agreement, and any dispute arising under it, shall be decided according to the New South Wales law. If this Agreement relates to more than one mare, it shall be constructed as a separate agreement in respect of each mare named in the agreement.
