A COPY OF THE MARES REGISTRATION MUST ACCOMPANY THIS FORM Conditions and breeding agreement of Kennallywood Stud For The 2023 Season :

1. Bookings: Please ensure that you have filled out the required forms, and that a deposit payment (booking fee) of \$220.00 accompanies this document. Please contact stud for payment details or cheques can be made payable to: Kennallywood Pty Ltd. Invoices will be sent to your email. Credit card facilities are available. The booking fee is deductible from for service fee and is valid for one breeding season only.

2. Service Fee: The remainder of the service fee is payable to the stallion owner Marg and Terry Borland once a 45day pregnancy scan has been conducted. All fees in this contract include GST. All invoices are due on receipt. The non – refundable booking fee is payable with return of this contract.

3. Chilled Semen: Collections if collected at the stud is charged out at \$330.00 plus freight. Please notify us as soon as possible (48 hours) before chilled semen is needed. The mare owner is responsible for the cost of semen shipping for frozen or chilled semen. The stud takes no responsibility for lost or damaged shipments. Fresh on Farm collections \$110.00

4. Live Foal Guarantee: This is defined as the following; A negative pregnancy test after the mare has been declared pregnant by a qualified vet, or a still born foal. (LFG) is given with return service the following season. If the foal does not stand up and nurse, the Mare Owner will be entitled to a return service. This guarantee applies only if the Mare Owner notifies the Stallion Owner within one week from death of foal. This notice must be accompanied by a Statement from a licensed Veterinarian. If the Mare is to be returned and the Mare Owner fails to deliver her for re-breeding the following year, then any and all fees will be forfeited, and the return service will be lost. There is no LFG on the return service. The Mare Owner will have to cover all cost other than the Service Fee.
