Breeding Fee

The service fee payable is \$3,300 including GST
The service fee entitles the mare owner to a live foal guarantee.

Non-refundable booking fee

The booking fee of \$550 including GST must be paid in full prior to shipment of chilled semen. Shipping semen fees are the responsibility of the mare owner. We guarantee to ship the highest quality semen, however, will make no guarantees or warranties and shall be not held liable for contamination or damage of semen during or after shipment, loss of viability or any other cost arising from shipment delays, damages or lost in transit. The booking fee is non-refundable and is deducted from the service fee and is valid for one breeding season only. (Subject to live foal guarantee)

Embryo Transfer YES NO

If more than one foal results from any (1) embryo flush, an additional stallion service fee of \$3,300 incl GST will be due and payable upon each successful pregnancy of said embryos on 45 day positive pregnancy test.

Live Foal

The mare is entitled to a free return to WP Smooth Talker if the foal dies within forty-eight (48) hours of foaling or if the foal is stillborn. In both cases a report certified by a practicing veterinary surgeon is required. The free return is only applicable to the year immediately following the breeding. All expenses (including shipment) incurred in achieving the return shall be upon the mare owner.

The live foal guarantee for the contract is non-transferable and non-assignable unless authorised by Waters & Henry 1 Pty Ltd. Should mare be sold or otherwise disposed of prior to the birth of the foal, the live foal guarantee shall be void unless prior authorised by Waters & Henry 1 Pty Ltd. If the mare dies or is unsuitable to breed, then the right to a free return is null and void.

Conditions

A copy of the mares registration certificate showing owner at the time of breeding **must be returned** with this contract. Unregistered mares can be covered.

Mare owner warrants the broodmare to be healthy and in sound breeding condition, this fact to be certified by a qualified veterinarian before the mare is served if necessary.

The mare owner agrees to notify the stallion's booking coordinator Amanda Latham in writing via email amanda@cwrural.com.au or via text 0418 420 676 of the pregnancy status of the mare at the 45 day pregnancy scan regardless if the mare is pregnant or not.

At 45 days an invoice will be issued and is payable for the balance of the breeding fee unless a negative pregnancy scan from a practicing veterinary surgeon is provided to the booking coordinator.

It is further agreed that should WP Smooth Talker be unavailable for any reason whatsoever before serving the said mare this contract shall be rendered null and void and the service fee or any fees paid (including booking fee) will be returned to the mare owner.

This contract shall not be assigned or transferred by the mare owner. In the event the mare is sold the service fee (if applicable) shall immediately become due and payable by the undersigned owner. Unless otherwise pre-authorized by stallion owners.

Australian Quarter Horse breeding certificates will not be issued unless the above-mentioned mare is registered with the Australian Quarter Horse Association at time of signing this contract. If a late stallion breeding return is required, the mare owner is liable to pay the late fee required by the Australian Quarter Horse Association. Australian Stock Horse breeding certificates will be issued to registered Australian Stock Horse mares.
