# 2024/25 SDP SCOTT DAVID SERVICE CONTRACT

THIS AGREEMENT is made and entered into thisda	ay c	of	2024/25

- 1. The mare owner agrees to pay the full Service Fee of for frozen, chilled semen or fresh on-site semen for SDP Scott David (the Stallion) for the 2024 breeding season (no live cover) with the provision of a service certificate upon a 45 day positive scan.
  - a. Option A: Repeat breeder \$1650 with \$500 booking fee
  - b. Option B: Single Booking: \$1980 with \$500 booking fee.
  - c. Option C: Multiple Mare discount \$1650 each with \$500 booking fee per mare.

## PLEASE NOTE FROM 1 JANUARY 2025 the services will increase to \$3,300 for single mare bookings or \$2,750 for multi mare and repeat breeders.

- 2. The **Booking Fee of \$500.00** is payable upfront per mare, with the reminder due on a 30 or 45 day positive pregnancy scan. The booking fee is deducted from the full Service Fee and is **non-refundable**.
- 3. Multi mare discounts apply when breeding 2 or more mares and to be eligible for the repeat breeder discount, you must have bred to SDP Scott David the year immediately prior.
- 4. No service certificate will be released until accounts are paid in full such as veterinary expenses, agistment and other charges incurred on behalf of the mare.
- 5. All collection and shipping costs for collected semen is separate to this contract and is payable by the mare owner.
- 6. Banshee Performance Horses are not responsible for Australia Post or Courier services and will not be accountable for any delays associated therewith.
- 7. Banshee Performance Horses undertake to use their best endeavours to provide semen as requested and in a timely manner. Frozen semen can be provided if chilled is unavailable.
- 8. A copy of the mare's registrations papers must accompany this contract.
- 9. All of the Stallion's semen remains the property of Banshee Performance Horses and may not be collected, stored, distributed or sold by any other party. The full service fee (Inc. GST) entitles the payee to the genetics of the stallion and a live foal guarantee on one foal only. The amount is payable by the person/entity named in this agreement to Banshee Performance Horses for each and every foal created by the stallion's semen.
- 10. This contract offers a Live Foal Guarantee (LFG) for one foal. However, after 2 attempts at service, if after consultation with the mare owner, vet and Stallion owner, a change of mare may be requested by the stallion owner with no additional charges payable for the service fee by the mare owner.

- The live foal guarantee becomes null and void if the mare owner returns the mare to work/competition after a positive pregnancy test. The live foal guarantee also becomes null and void if the mare does not receive a 45 day pregnancy scan.
- 12. The Mare Owner must provide confirmation of the 45 day scan, with service date details by no later than 1 April 2025 or any late service returns will be at the cost of the Mare Owner.
- 13. All mares must be tractable and handled to lead. Banshee Performance Horses reserves the right to refuse any mare for any reason.
- 14. It is further agreed that should the Stallion die or become unfit for service, then this contract shall become null and void, and any money paid as a part of the service fee shall be refunded less any veterinary and agistment fees.
- Mare owner agrees that Banshee Performance Horses will not be responsible for any disease, accident, sickness, or death to the mare owner's mare or foal, and that Banshee Performance Horses will exercise their judgement in supervising and caring for mares. Mare owner will likewise not be responsible for any disease, accident, sickness or death to the stallion or mare.
- Mare owner agrees to have Banshee Performance Horses Veterinarian check the mare for normal breeding condition, and to perform such other veterinary services that Banshee Performance Horses deems necessary, at the mare owner's expense. This includes worming, treating infections, preventative measures, original examination, pregnancy checking, treatment of any illness/injury, etc.
- 17. In the event that the mare aborts or if the foal does not stand to nurse, it is agreed that the mare owner may return the mare for breeding during the following breeding season and no stud fee will be charged for subsequent breeding. To be entitled to such subsequent breeding the owner must deliver to Banshee Performance Horses a certificate by licensed veterinarian attesting that the mare aborted or that the foal failed to stand and nurse, accompanied by Stallion service Certificate and such delivery shall be made within seven (7) days of the date that the mare aborts or the foal is born.
- 18. It is agreed that all service fees are payable to Banshee Performance Horses care of Sam and Sarah Campbell of 1847 Inverramsay Road, Goomburra QLD 4362. Interest will be charges on overdue accounts sent for service fees, agistment and veterinary expenses. Interest will be charged at 5% of invoice total on any invoice total on any invoice not paid by the due date as stated on the invoice. This applies to any invoice sent by Banshee Performance Horses.
- 19. When the mare owner signs and returns one copy of this contract with the fully paid Booking Fee it will be a binding contract on both parties subject to the above terms and conditions.
- 20. This contract is not transferable or assignable.
